# MACKAYE HARBOR WATER DISTRICT BOARD OF COMMISSIONERS MINUTES April 20, 2020

# **CALL TO ORDER**

The Board of Commissioners for MacKaye Harbor Water District met on April 20 via the internet. Chairman Olson called the meeting to order at 5:33 p.m. Present were commissioners KC Jennings and Dean Anderson, manager Wayne Haefele and clerk Helen Cosgrove.

### **REGULAR BUSINESS**

## A. Approval of February 22 workshop and March 16 meeting minutes

Olson moved, seconded by Jennings to approve the February 22 workshop minutes. The motion passed unanimously. Anderson moved, seconded by Olson to approve the minutes of the March 16<sup>th</sup> meeting. The motion passed unanimously.

## B. Approval of Vouchers and Payroll

Cosgrove distributed the claims payment request forms; additional expenses included invoices from A & A Well Drilling. Anderson moved, seconded by Jennings to approve payment from the general fund vouchers in the amount of \$7,349.94 and payroll in the amount of \$384.00. The motion passed unanimously.

#### C. Financial Report

Cosgrove distributed the general fund report; have \$43,000 in the fund. Gave Haefele the Small Water System Management Plan for his review; reported that one customer has not paid their bill.

#### D. Manager's Report

Haefele reported he had updated the website; the first quarter of 2020 had the lowest water use ever. Had been following correspondence with Pat Roe; spent time with Arnott at the pumphouse diagnosing the low/no water pressure issues primarily in Salmon Point; had Arnott try several things that may resolve the issue. Olson said one of the customers has a lot of air in their line, while Olson was not experiencing that problem. Arnott will continue to work on resolving the issue. Jennings thinks there is still air trapped at the residents at higher elevations and suggested putting in back flow restrictors on any residence above the tanks and storage units.

Haefele said he perused through the copy of the SWSMP and wants to exclude a number of pages that the DOH inserted; take out pages that are useless. Cosgrove told Haefele that he could do anything he wanted to the plan.
